As many people may find it difficult to make a single large property tax payment once a year, the Town of Qualicum Beach offers a Tax Prepayment Plan to allow tax payers to contribute a fixed monthly payment towards their estimated net property taxes for the following year.

Preauthorized payments for 2024 taxes may start from July 10 of 2023 until May 10 of 2024 (maximum of 11 payments in total – there is no payment for the month of June). The maximum prepayment amount is initially calculated by dividing the gross property taxes (most recent levy), less the anticipated home owner grant, by the number of months remaining until the month of May. If property taxes were based on land only and a new home has recently been constructed. gross tax will determined based on an estimated assessed value.

Each year, prior to the July 10 start date, the monthly prepayment amount for next year's taxes will be recalculated based on the current year's levy. A letter will be mailed to the property owner advising them of the change.

The tax payer may choose to pay any amount less than the maximum prepayment amount.

Any change to the prepayment amount or to the taxpayer's bank account must be received 7 days prior to the next prepayment. Modification forms are available at the Town office.

Interest will be paid on the prepayments at 2.5% below the prime rate established by the principal banker to the Province, and no lower than a minimum of 1.0%. Rate settings occur on the 1st of January, April, July and October of each year. The current rate is 4.2%.

The annual tax notice will show the current year's tax levies, less the total prepayments and interest earned. It will then be the owner's responsibility to pay any difference, and if eligible, claim the Provincial Home Owner Grant. Due dates and tax penalties, as stated on the notice, will still apply.

Unless cancelled by the property owner, or an outstanding balance remains, the Tax Prepayment Plan would continue starting July 10 for the following years' property taxes.
