Cheryl Dill, Executive Director, and Lorrie Mohl, Employment Services Coordinator, provided an overview of the purpose, services and expertise provided by the Career Centre, an initiative of the Central Vancouver Island Job Opportunities Building Society.

- Services provided to job seekers include job readiness preparations, employment consulting and plans, training support, self-employment support, and wage subsidy.
- Employers are supported through free job postings with recruitment coaching, an annual hiring fair, educational workshops, employment-related advice, an employer newsletter and "Pulse Check" poll, and a wage subsidy program.
- As of March 2023, the unemployment rate is 4.5% for British Columbia and 3.6% for Vancouver Island.
- Local employment opportunities (gaps) include healthcare occupations (all levels), Class 1 and 3 Drivers, Early Childhood Educators, Community/Mental Health Support Workers, Bookkeepers, and Personal/Residential Care and Maintenance.
- Training is available for identified skill gaps in areas such as Early Childhood Education, Forestry/Natural Resource Worker, Mental Health Support Worker, Dental Receptionist, Adaptive Trail Building, and Website Design.

• Noting that May 5 marks 'Red Dress Day' to honour the memory of the murdered and missing Indigenous women and girls.

- Attending the Association of Vancouver Island and Coastal Communities (AVICC) convention in April, noting that the Town's resolution in support of Broom Busters was passed unanimously.
- The Regional District of Nanaimo recently re-established a Select Committee to consider adding Electoral Area E as a participating area, review options and models for the District 69 Swimming Pool Service, as well as an additional aquatic facility in Oceanside.

Notice of Motion - Food Security

Mayor Westbroek MOVED and Councillor Vander Valk SECONDED,

THAT staff be directed to refer the following matters of Food Security, including but not necessarily limited to:

- The role of local government and the community to safeguard and enhance local food security.
- Impacts of climate change, post-pandemic adjustments, war, poverty, inflation, food prices, and disrupted food supply chains on food security.
- Growing, processing, and eating food as the largest contributor to greenhouse gas emissions of any human activity.
- The importance of addressing food security sooner than later.
- The "Five A's of Food Security": Availability, Access, Adequacy, Acceptability and Agency.

(2) **Public Safety** (Councillor Scott Harrison)

Councillor Harrison commented on the following:

- Housing affordability, lack of rental stock, and the impact on our most vulnerable residents, noting the steep increase in fentanyl overdose rates in seniors.
- Attending the Day of Mourning event; 181 B.C. workers lost their lives to workplace injuries and illness in 2022. Discussing resources available, including the 'Tailgate Toolkit' to increase access to harm reduction services and ideas for those in the construction industry.
- Impacts to local businesses from the inability to find workers due to the housing crisis.

Notice of Motion - Nanaimo Rent Bank

Councillor Harrison MOVED and Councillor Skipsey SECONDED,

WHEREAS 52.2% of renters in Qualicum Beach spend over 30% of their income on shelter costs, compared to the provincial average of 37.8%;

WHEREAS the CMHC rental market data indicates a vacancy rate of 0%; THEREFORE, BE IT RESOLVED, THAT the Town of Qualicum Beach provide Connective Support Society, who operate the Nanaimo Rent Bank, \$10,000 as part of the 2023 budget.

- May 2, gave a tour of the Council Chamber to grade 2 students from Qualicum Beach Elementary School.

WHEREAS the Ministry of Forests and the BC Wildlife Service have provided notice of a new Wildfire Risk Reduction program to mitigate fire hazards in the 1.94-hectare project area surrounding the Eagle Park Care Facility and the BC Ambulance Station; WHEREAS the Town of Qualicum Beach Tree Protection Bylaw No. 725, 2023 is not applicable to project area, as provincial and federal lands are exempted from this municipal bylaw;

WHEREAS a fuel management plan has been developed by a Registered Professional Forester (RPF) team for the project area;

THEREFORE, BE IT RESOLVED, THAT Council sends a letter to the Ministry of Forests and the BC Wildfire Service, copied to MLA Adam Walker, formally requesting a discussion regarding the fuel management plan with the RPF team and provincial representatives, in conjunction with a Council walkthrough of the forest around Eagle Park Care Facility and the BC Ambulance Station where fire hazard mitigation work is to take place.
